In accordance with the Government's requirement for all governing bodies, the 3 core strategic functions of St. Anne's R.C. Primary School Governing Body are:

- Holding the Head teacher to account for the educational performance of the school and its pupils
- Overseeing the financial performance of the school and making sure its money is well spent

- Religious Education is to be in accordance with the teachings, doctrines, discipline, general and particular norms of the Catholic Church
- Religious worship is to be in accordance with the rites, practices, discipline and liturgical norms of the Catholic Church
- At all times the school is to serve as a witness to the Catholic Faith in Our Lord Jesus Christ

Governance Arrangements

The Governing Body of St. Anne's R.C. Primary School was re constituted in 2014 under the School Governance (Constitution and Federations) (England) (Amendment) Regulations.

The Governing Body of this school consists of

- 7 Foundation Governors (2 positions currently vacant)
- 1 Parish Priest
- 1 Governor appointed by the Local Authority
- 1 Elected Parent Governor (1 position currently vacant)
- 1 Head Teacher
- 1 Elected Staff Governor

The full capacity of the governing body is 12.

A list of Governors, business interests and their roles can be found on the school website and as attached at Appendix 1 to this document.

The full Governing Body meets once each term, and we also have sub committees to consider different aspects of the school in detail. The two main sub committees meet at least once per term.

We have 2 main sub committees following a decision made in 2018 to streamline meetings within the National Review of Governance process. These are:

- Finance & Resources (Strategic planning, Finance, Health & Safety, Human Resources, Risk Management & Buildings)
- Curriculum and Monitoring (Progress and attainment for all groups of pupils, curriculum development)

We also have committees that meet if required to consider pupil discipline, admissions, appeals, and matters of exclusion.

Governors regularly visit school to monitor key aspects of the school's development and provide support and challenge to the school and Head Teacher. Individual governors have visited the school to monitor as follows:

- Safeguarding issues and training
- Analysis of data pupil premium, sports premium, attainment overall, SEND etc
- Book scrutinies
- Governor training
- Nominated governor meetings with subject leaders
- Meetings with the Faith and School Councils
- Health and Safety walk rounds
- Attendance of assemblies
- Lesson Observations / Deep Dives

Attendance Record of Governors

Governors generally have a good attendance at all main GB meetings and Committee meetings. Meetings have to be attended by a minimum number of Governors to ensure that our decisions are legally binding (quorate). Governing Body minutes indicate the attendance at each meeting and any queries can be addressed to the clerk.
